### Location

The Summer Activity Days will be located on the grounds of the Catholic Church of the Holy Name (80 Payneham Rd, Stepney 5069), Linde Reserve (43-45 Stepney St, Stepney 5069) and Dunstane Grove (62 Nelson St, Stepney 5069). There will also be two excursions to Kartmania Gepps Cross for laser tag (1 Port Wakefield Rd, Gepps Cross 5094) and TreeClimb Adelaide (Cnr Greenhill Road & Unley Rd, Adelaide 5000).

### Drop off and pick up:

Children are to be dropped off and picked up from the Catholic Church of the Holy Name (80 Payneham Road Stepney, SA 5069) on all three days. Children **must** be signed in and out by a parent or guardian. If of sufficient age, children who have been granted permission to make their own way to and from the Activity Days, must sign themselves in and out.

### Early Drop-Off and Late Pick-Up:

- Volunteers will be on duty from 7:45am each morning on the grounds of Holy Name Church. Children **cannot** be signed in before 7:45am.
- Please ensure children are promptly picked up from the Holy Name Meeting Room at the end of each day. If you are running late, please call or text Bianca Fisher (0426 562 830) or Fr Sofatzis (0429 808 958).

### Cost:

- Standard Fee: \$30 /child **per day**, or \$90/child for all three days
- Family of 3 or more: \$270 (the 4<sup>th</sup> or more child is free).
- Please contact Fr Sofatzis or Fr McCaffrey if you would like a concession. No one will be turned away for financial reasons.

### Meals:

The above cost includes all meals (breakfast, lunch, afternoon-tea & dinner). We are able to cater for children who are *dairy free*, *gluten free* and/or *nut free*. In the case of all other dietary requirements, you are most welcome to send your child with his / her own meals.

### Registration

**The due date for registrations is STRICTLY Friday 12<sup>th</sup> January. Final numbers need to be confirmed by this time for booking and catering purposes.** To register, please complete the registration forms (found following) and hand them to either Fr Sofatzis or Bianca Fisher in person. ### Payment

### Travel:

Parents / guardians are responsible for bringing their children to and picking them up from the Church of the Holy Name on all days. For the excursions to TreeClimb and Lazer Tag, children will travel in cars and / or hired buses.

### Privacy:

All information contained in registration forms or collected during the “Summer Activity Days” (Adelaide) is confidential and for the use of the Adelaide Latin Mass Community, the Catholic Archdiocese of Adelaide and the Priestly Fraternity of St Peter for follow-up, emergencies, and administration. It may need to be shared with government agencies for statistical purposes or the police, where safety is a concern. Legal guardians of children may request to see or update this information at any time.

### Use of Photos / Video:

During the Activity Days, photos/video footage may be taken of children in appropriate settings. We may like to use such photos/footage for the purpose of promoting the work of the Adelaide Latin Mass Community and the Priestly Fraternity of St Peter. - I give permission and consent for my child (children) to participate in all activities of these Activity Days (including sports, outdoor events and excursions), including activities at (and walking by foot to and from) Linde Reserve and Dunstone Grove; and excursions to (including transportation to and from, and activities at) the aforementioned TreeClimb (Adelaide) and Laser Force / Kart Mania Gepps Cross (Gepps Cross).
